- Certification / Non-Certification of Firefighter / Paramedic candidate(s) on October 2023 final eligibility list: Commissioners certified one candidate for continuation in the hiring process; all aye; list is now exhausted / expired
- 3. Certification / Non-Certification of Fire Lieutenant candidate(s) on May 2022 final promotional eligibility list; Commissioners certified one candidate for continuation in the hiring process; all aye
- 4. Certification / Non-Certification of Police Officer candidate(s) on August 2023 final eligibility list: Commissioners certified one candidate for continuation in the hiring process; Commissioners did not certify the continuation of four candidates and names will be removed from the eligibility list; all aye; list is now exhausted
- 5. Certification / Non-Certification of Police Officer candidate(s) on February 2024 final eligibility list: Commissioners did not certify the continuation of ten candidates and names will be removed from the eligibility list; all aye
- 6. Certification / Non-Certification of Maintenance Worker I candidate: Commissioners certified the continuation of one candidate in the hiring process; all aye
- 7. Discussion of Public Works hiring for Maintenance Worker I: Commissioners discussed review of the hiring process for Maintenance Worker I positions with Director of Public Works Heather Galan. After review of previous correspondence provided and discussion of hiring challenges, the Commission recommended and agreed with future recruitments based on division vacancy – either specifically Street or Utility; Commissioners express the desire to remain a part of the candidate review process and recommended future screening processes follow the Lateral Police Officer process - staff would recruit, interview, and screen the candidate, including background and medical; when fully vetted, interview summary and background review will be provided to the Commission and interview scheduled for final hiring confirmation. The Commission also approved only a quorum needs to be present for interviews. Department expects possible vacancies in next few weeks – staff will follow the process as a trial and a future rules and regulations update will be brought forward to modify the Commission process once the new method is tested.

Commissioners also discussed topics for the May 21st meeting with Police and Fire Departments.

Commissioners were reminded of the Lateral Police Officer candidate scheduled for interview at 6:00 p.m. on May 21st
