

Q1 Are you a resident of the Village of Gurnee?







This will only open up a Pandora's Box of safety threats and economic risk. The use of vapped 10/8/2019 3:31 PM THC leads to severe health issues. There is no way for a field check aka breath test, during traffic stops with vapped THC users. In June I asked a nearby deputy chief of police how they could test for vapped THC during traffic stops. He said, 'Vapped THC is odorless and smokeless, there are no tells. Today, the best way to check is to look for empty snack bags." I visited Denver a month ago, the first time since legalization. 5% of the service sector employees I encountered exhibited signs of THC intoxication. I was told of workers and managers who consumed marijuana during work breaks at a beverage plant. These employees then resumed using heavy equipment, working production lines or supervising work despite being intoxicated and against the law. Do we want this in our community's manufacturing base. Furthermore, retail stores (a novelty store and an oriental gift shop) at a Broomfield, CO shopping center I visited openly sold marijuana or drug paraphernalia in the open. Do we really want that? My interactions with medical professionals, to a one, do not recommend marijuana for pain management or other maladies. Their considered opinion is that marijuana doesn't treat symptoms, it makes patients "not care about their pain." Medication should focus on treatment of illness, not a source of ennui in the chronically ill. They also stated that there are no standards for dosage from the FDA. As we've seen of late with vapping related illnesses and deaths, many were related to THC. The use of infused products present potential for overdose, as we have also seen with the hospitalization of children sickened by consuming THC infused gummies or baked goods. We as a community, have invested greatly in teaching our kid not to use illegal drugs. What message does legalization send to our kids? In my professional career, I have never worked with a THC user who would be considered successful, quite the opposite -they are poor performer that dragged companies down for loss of productivity, lost sales or scandalous public behavior. As a reminder, marijuana is illegal at the federal level and its prohibition is mandated by international treaty obligation. This sort of state level legalization could easily be undone by the Federal government or by Federal lawsuit brought by a person as a consequence of injury by crossing state lines. Of course this would happen years after the initial and long term damage to the community is done. Furthermore, legal weed has been found to encourage the illegal drug trade -illegal dealers undercut government managed markets and legalization removes legal and societal barriers to adult consumption, thus massively increasing potential demand. This 'legal cover' encourages illegal interstate shipment of THC to other states where it is illegal. We have seen that with Gurnee police seizures of vape cartridges manufactured in Colorado with 80mg THC content. My family is terribly concerned about undetected drivers under the influence of THC on the roads causing injury and death -our village is a crossroads I was particularly offended by the suggested locations. The last thing the East Grand Corridor needs is legal weed. Would a business want to locate on the East Grand Corridor. Truthfully I view it as a money grab from people outside of Gurnee -take the money let other towns deal with the fallout. The Hunt Club and the East Grand Corridor is horrible as we are a town that lives on tourism. Gurnee Mills hosts 20 million visitors a year, Great America hosts 3 million and the source of the village revenue (instead of property taxes). Legal weed only serves to turn off or offend visitors with families. I would point out that travelers to the hoped for sports complex would pass through there. Could it be this is another attempt to grab the money from out of town visitors and shift the impact to other communities or an angle to allow associated item sales in Gurnee Mills. Remember the revenue the village would gain is a fraction of what could be lost by repulsed visitors. In closing, this is a single issue voting decision for my wife, daughter and me. We live in Gurnee and will absolutely vote against any trustee or mayor who supports legalized marijuana. The same is true of our circle of friends with children in the village. My call to action for the village is to: 1. Ban the establishment of medical dispensaries, recreational marijuana facilities and self cultivation. You have only one window to do this! A year from now, we would not be allowed to impose restrictions. 2. Encourage surrounding communities and those along transportation corridors to ban marijuana to limit impact to Gurnee. 3. There are 250,000 people who pass through Gurnee daily (2011), we are a transportation crossroads. Beef up sobriety and DUI efforts to interdict THC impaired motorists. Support those efforts materially and publicly. 4. Step up police efforts in schools to stop underage vapping as it will become much easier for kids to obtain THC products and use them without the telltale indicators. 5. Step up material and public support for ROAR and DARE type programs. They work and reinforce the danger of THC use. Remember, we are Gurnee voters and this is a singular issue for our vote. 
