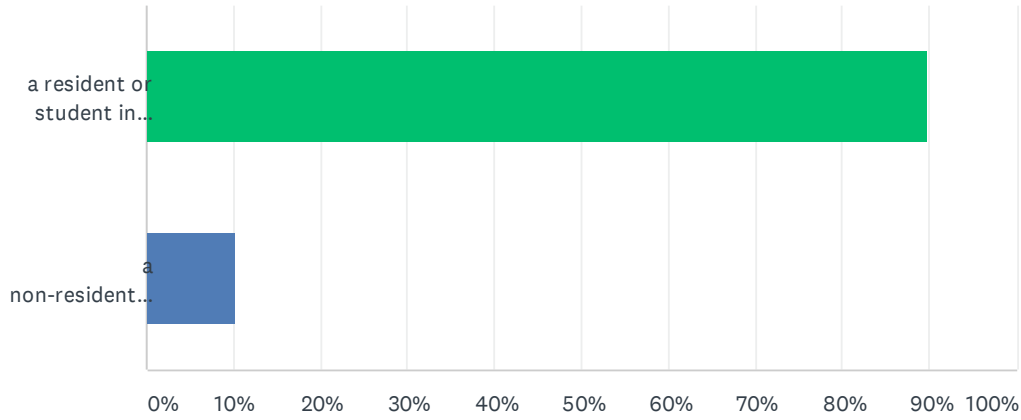

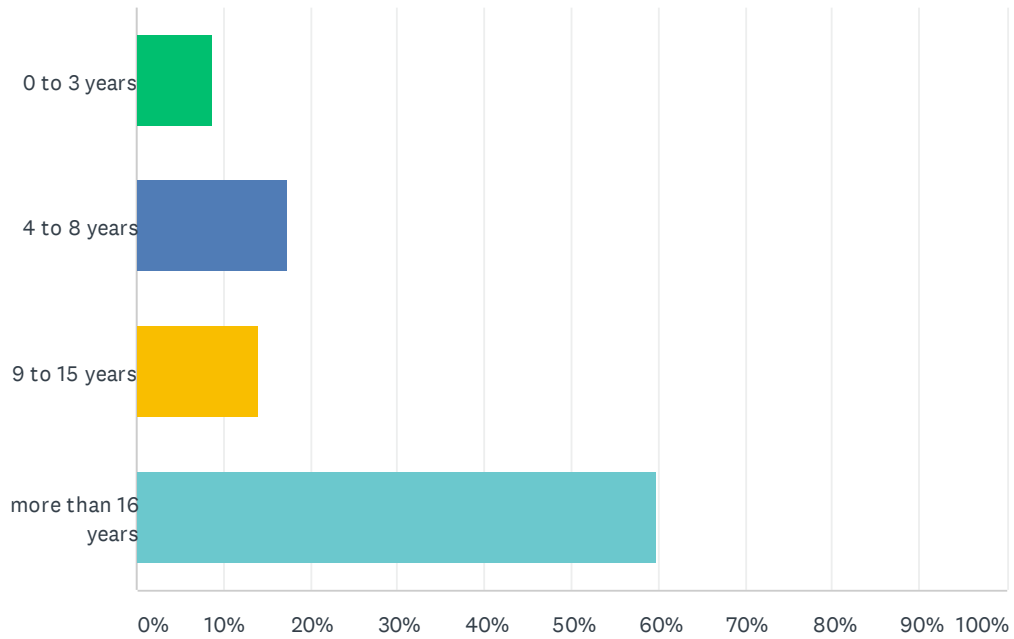

## Q2 How long have you lived in Gurnee?

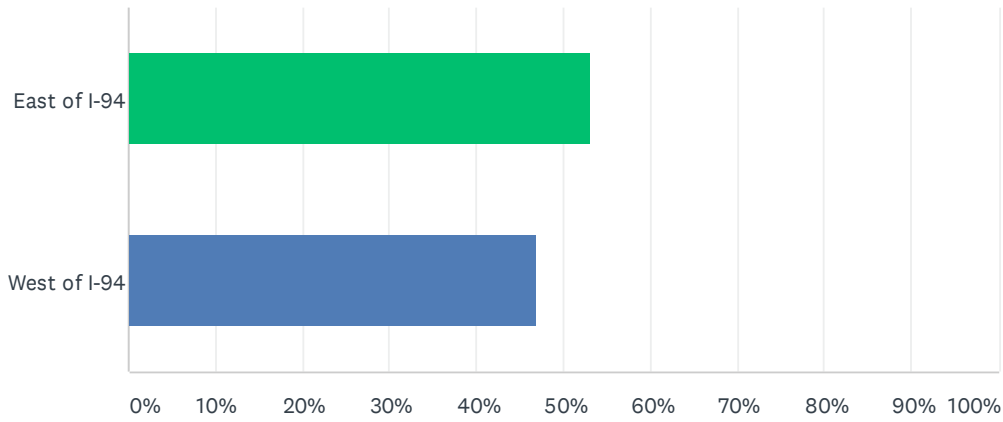

### Q3 What part of Gurnee best describes where you live?

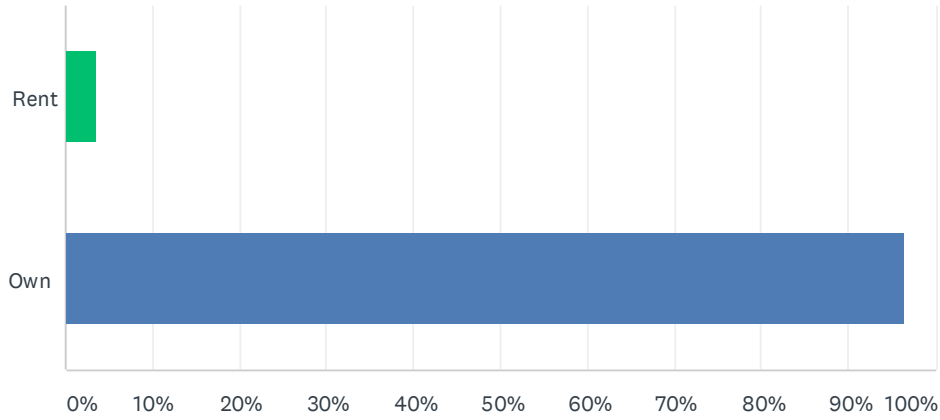

## Q4 Do you or your family rent or own your residence?

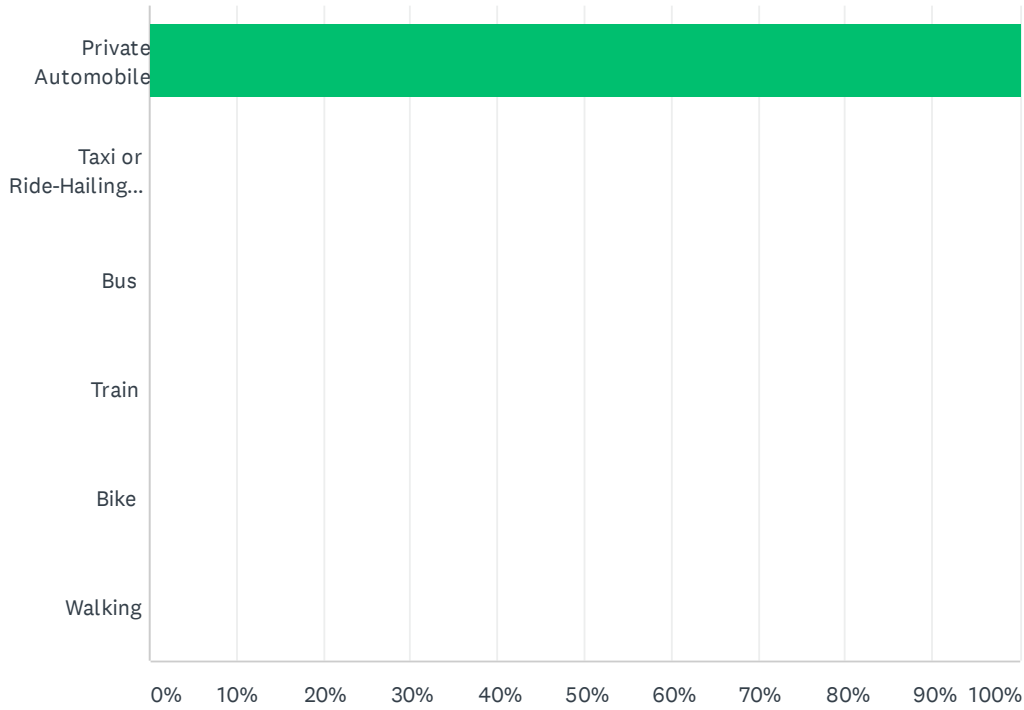

## Q5 What is your primary mode of transportation?

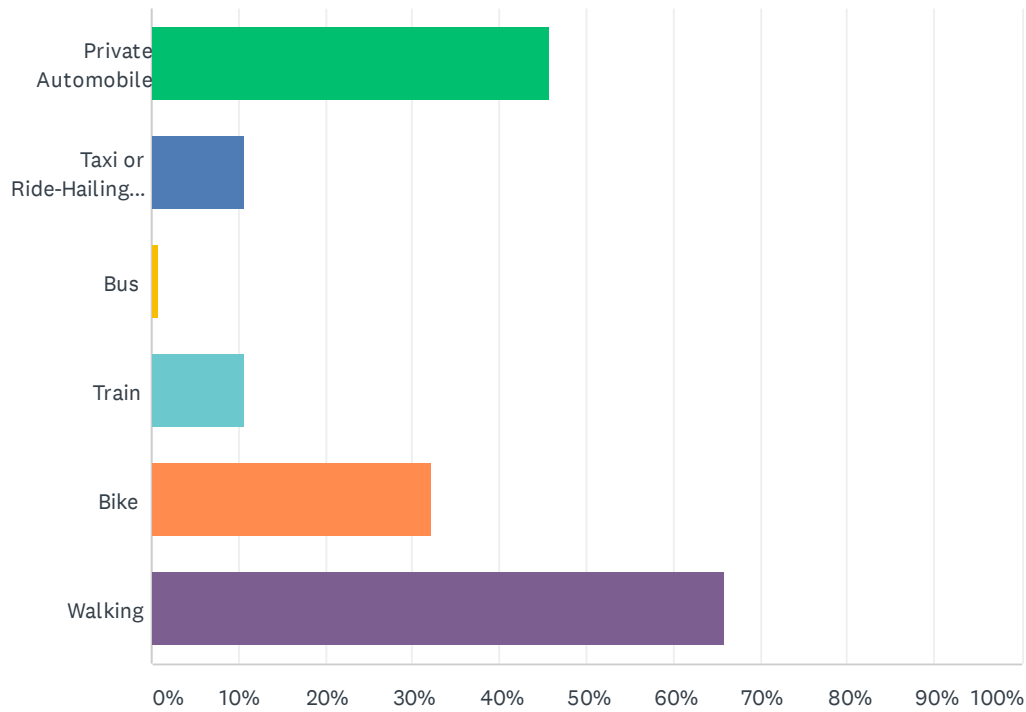

## Q6 What other transportation modes do you regularly use?(check all that apply)

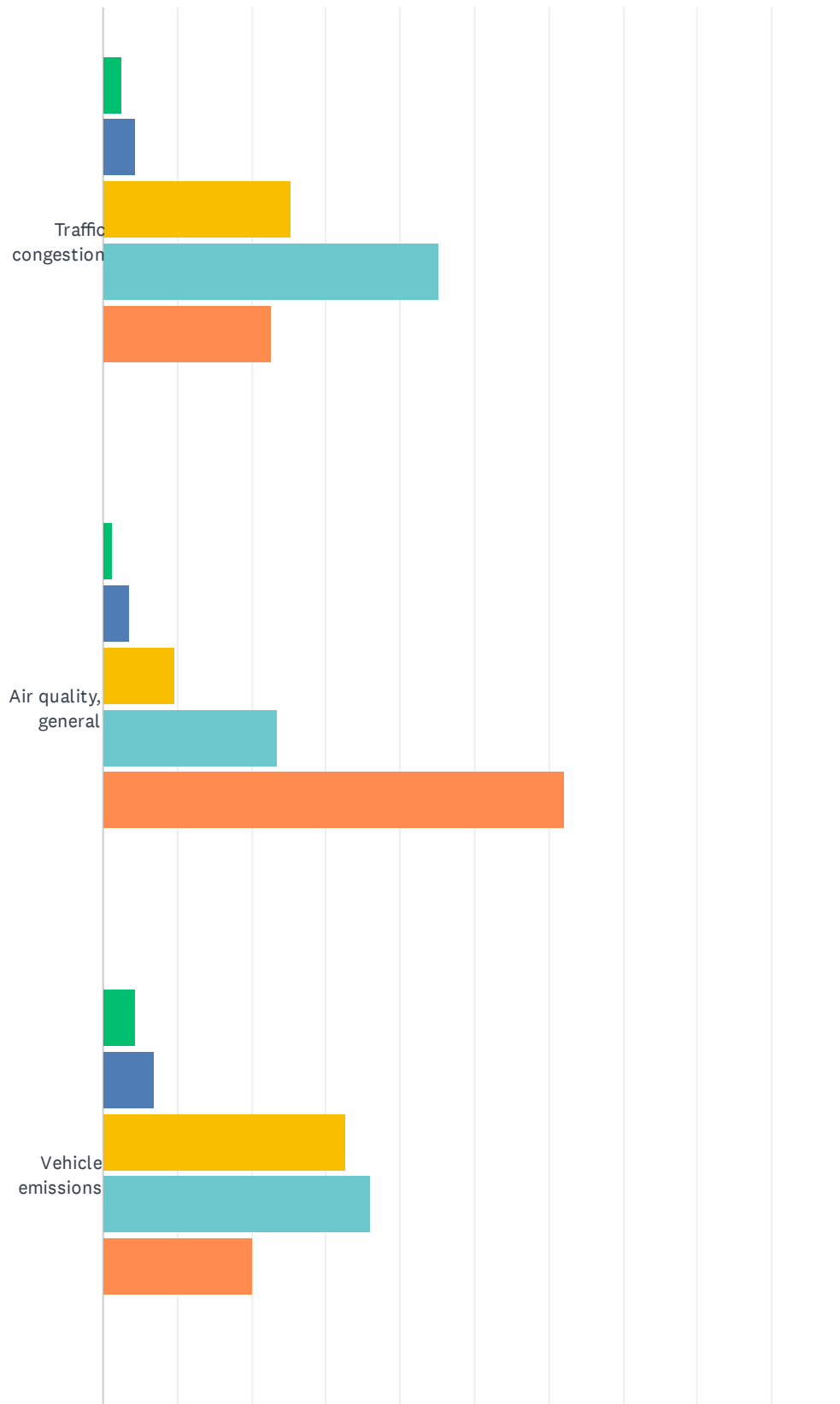

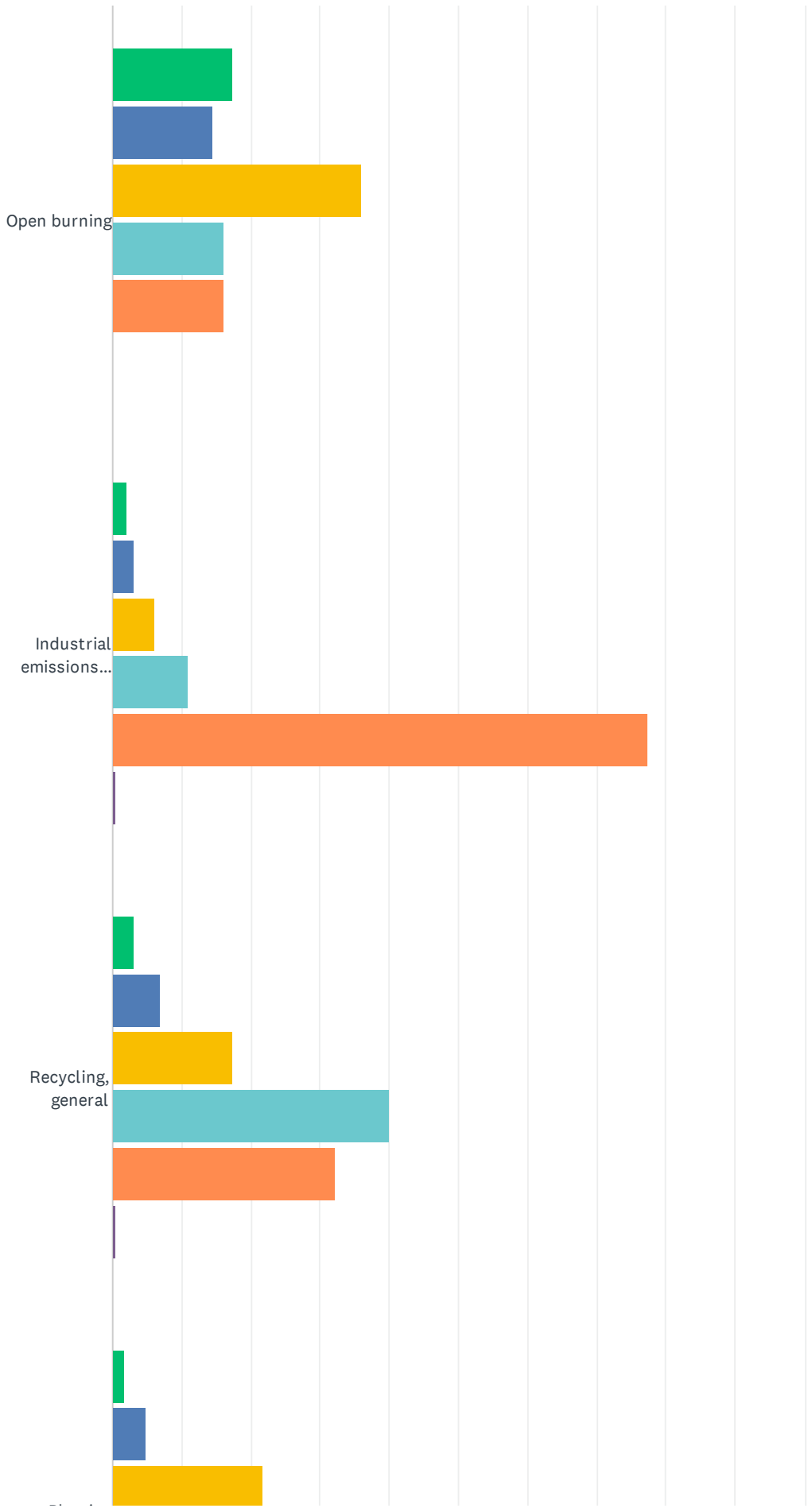

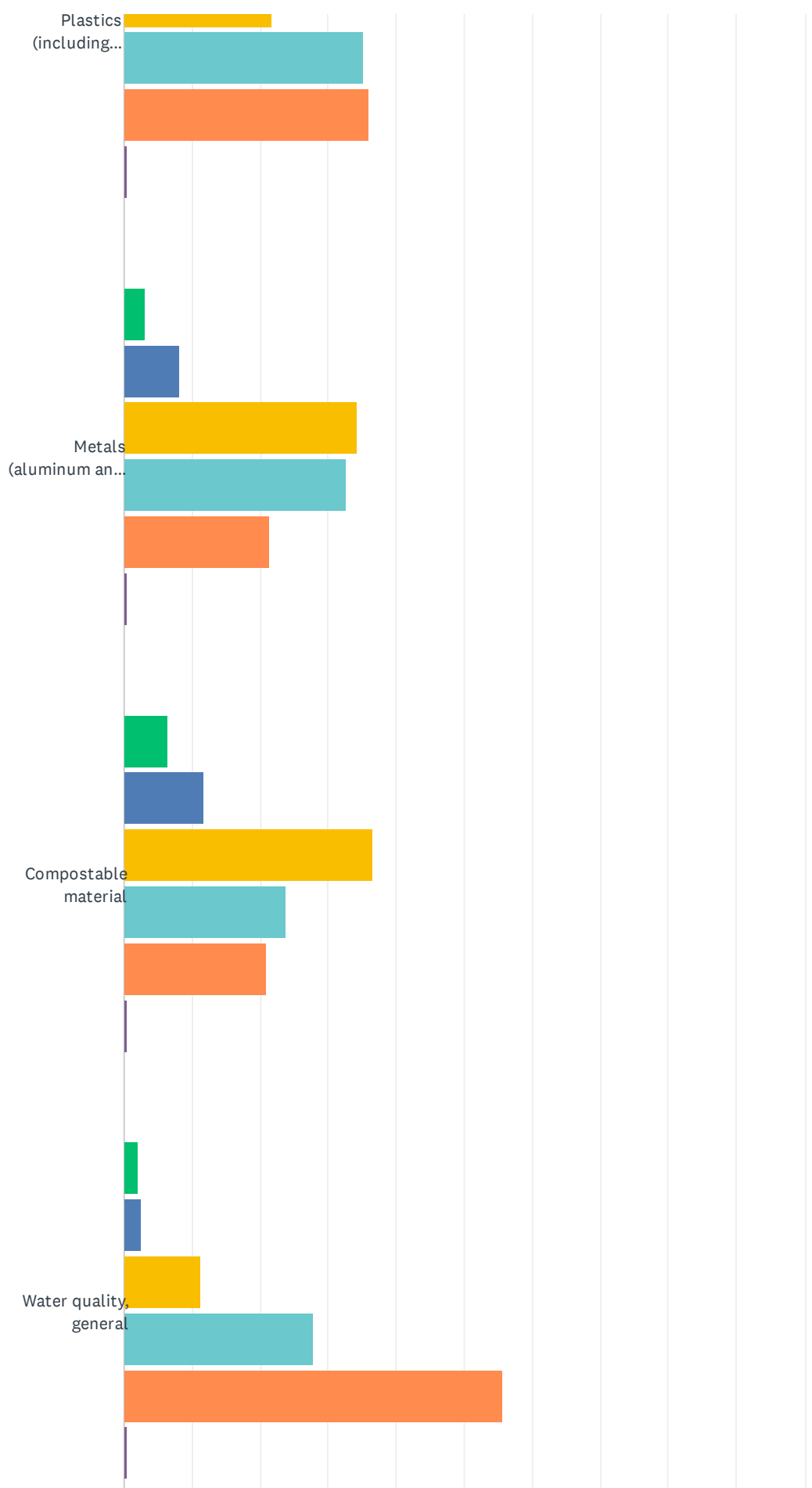
# Q7 How concerned are you about the following aspects of environmental sustainability?

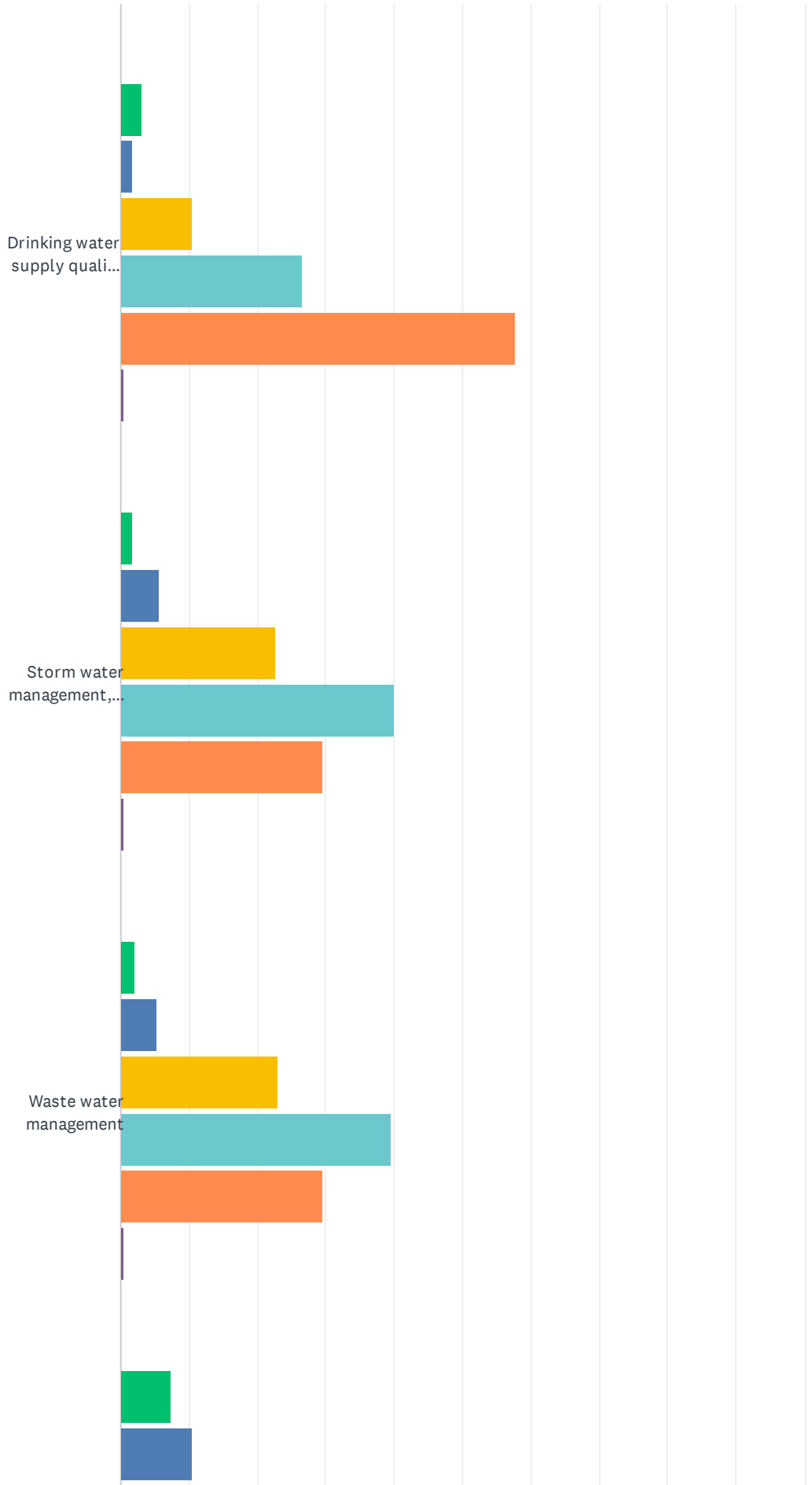

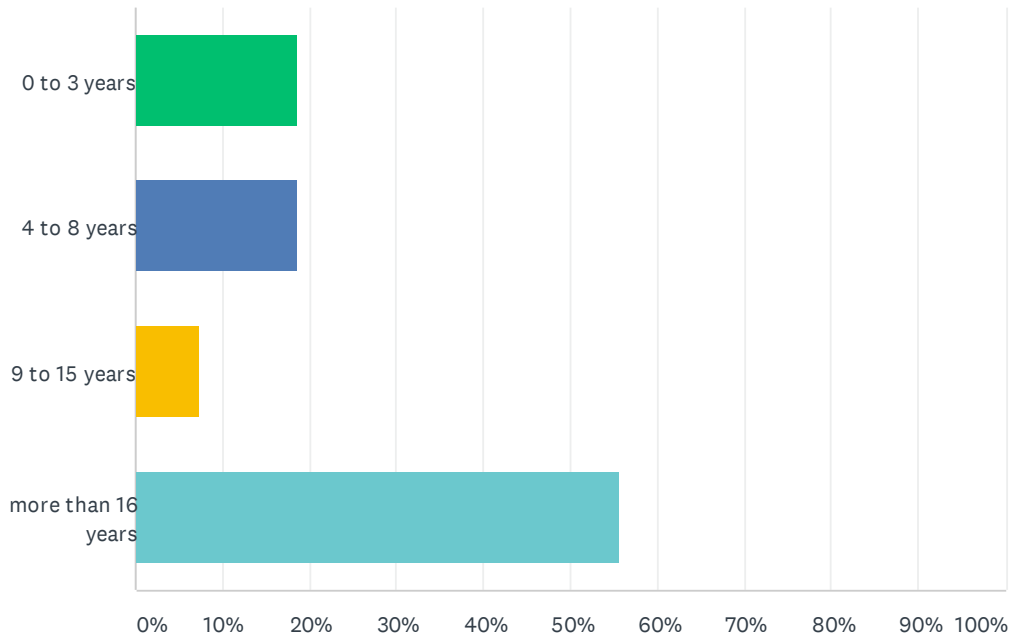

### Q9 How long have you worked or otherwise been associated with Gurnee?

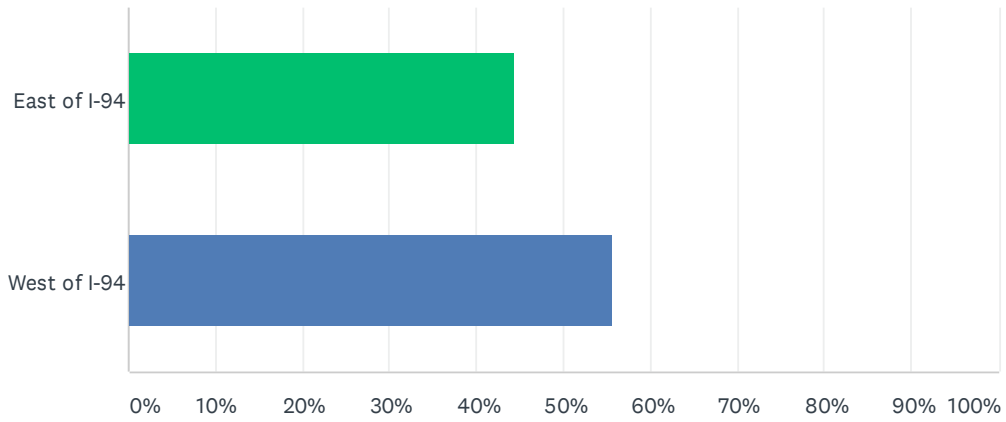

### Q10 In what part of town are you engaged?

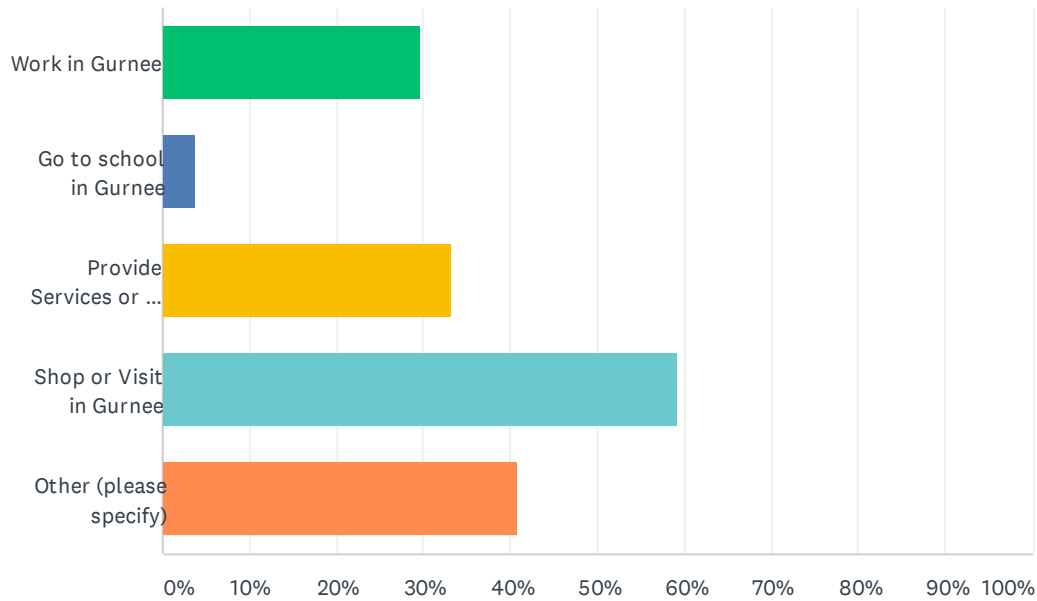

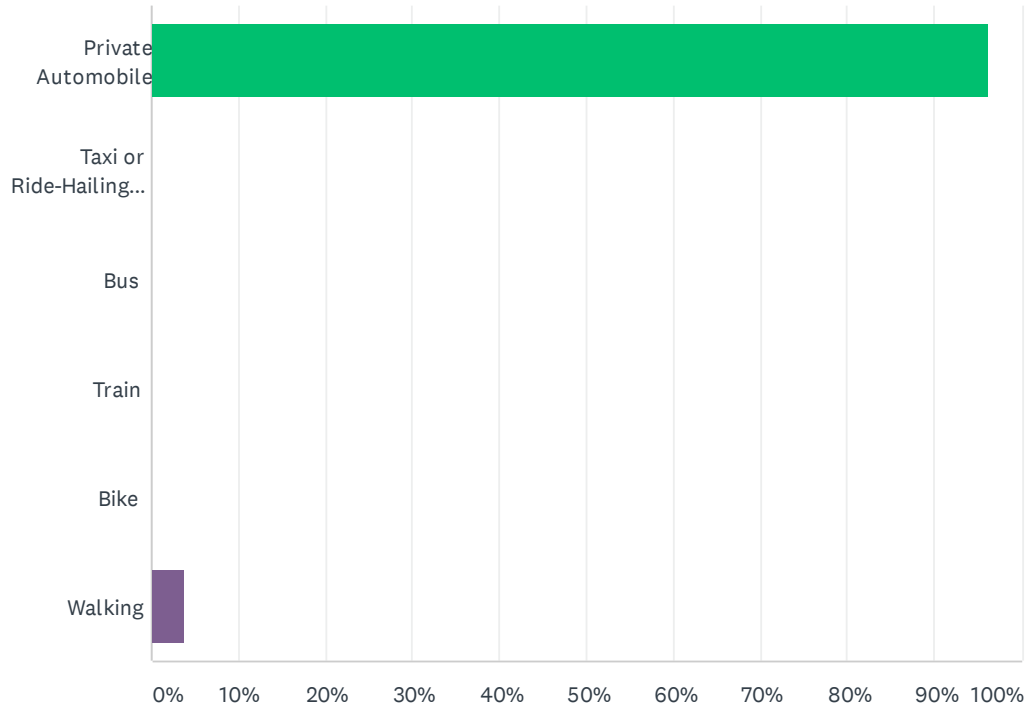
