## G. NEW BUSINESS

1. Approval of Ord. 2017 - 44 accepting the Final Plat of Ashbury Woods of Gurnee.

Mr. Muetz said the Final PUD Plan for the Ashbury Woods development was approved at the August 21st Village Board

meeting. It is located on the east side of Hunt Club Road north of Orchard Valley Estates and includes 18 residential units with an average lot size of .33 acre. As was stated at the August 21st meeting, the Final Plat of Subdivision would be before the Board at a future date. He continued to say at this point, it is now ready for Board consideration. The subdivision plat is in conformance with our Subdivision, Tree Preservation and Zoning Ordinances, with 2 deviations;

- Developer is proposing a fee in lieu of installing sidewalk (as was included in the PUD agreement that has already been approved); and
- Reduction of right-of-way width to 50 feet. The Planning and Zoning Board is forwarding a favorable recommendation on the Plat. It is now ready for your consideration.

Trustee Jacobs said the Village has spent a lot of time talking about sidewalks and asked if the fee in lieu of works against the desire to increase pedestrian mobility.

Mr. Muetz said he did not think so as the funding can be used in areas that are a higher priority.

Mr. Ziegler said there will be sidewalks on both sided of the road within the subdivision and that fee in lieu of is for sidewalk along the east side of Hunt Club. He continued to say installing sidewalk here would not make much sense are there is not sidewalk to the north or south and most of the sidewalk along Hunt Club is on the west side of the roadway.

Trustee Thorstenson said recently our Blue Ribbon Committee rated potential sidewalks and asked if these sidewalks were rated in terms of priority.

Mr. Ziegler said the east side of Hunt Club was not a high priority and may not have been rated. He said the west side is a priority.

Attorney Winter that was more an issue regarding the right of way and portions of this stretch is in the County.

Trustee Garner asked where the fee in lieu of money is put.

Mr. Ziegler said it goes into the sidewalk impact fund.

Mr. Muetz said the last couple years the Village has been using Impact Fee funds to complete improvements to sidewalk, stormwater and roadway systems.

It was moved by Trustee Hood, seconded by Trustee Garner to approve of Ord. 2017 - 44 accepting the Final Plat of Ashbury Woods of Gurnee.
