 - Unless changes made that affect stormwater
 - Allows up to 6 months from October 2019 for communities to enforce new rainfall

Trustee Ross asked if the funding collected in Gurnee will still allow access to other LCSMC funding. Galan responded that the Village most likely will not be able to apply for direct funding since we are collecting funding on our own for our direct benefit.

Mayor Kovarik said while the Village may not be able to apply directly, LCSMC funding may result in projects outside the Village that have a positive impact on our watershed.

Administrator Muetz said consideration to adopt the updated Watershed Development Ordinance will be on the next agenda.
