G. NEW BUSINESS

1. Approval of Ord. 2021 - 31 approving the appointment of the Director and Alternate Director as representatives to the Central Lake County Joint Action Water Agency.

Administrator Muetz said the Village receives water through its membership in the Central Lake County Joint Action Water Agency (CLCJAWA). As a member, the Village is required to appoint a Director and Alternate Director to sit on the Board of Directors. These positions are 2 years terms that expired on April 30th. The Mayor of each community typically serves as the Director. Trustee Balmes has served as the Alternate Director for 15 years and based on her past experience and willingness to continue to serve, Mayor Hood is recommending her reappointment. Administrator Muetz stated he also participates in the Agency by sitting on the Executive Committee, which reviews material and makes recommendations to the Board of Directors.

2. Approval of Ord. 2021 - 32 amending the Intergovernmental Agreement establishing the Solid Waste Agency of Lake County, Illinois.

Administrator Muetz said the Village of Gurnee is a member of the Solid Waste Agency of Lake County. He stated he serves as the Village's appointed Director and sits on the Executive Board, while Assistant to the Administrator Linehan is our Alternate Director and represents the Village at Full Board meetings. On April 15th the SWALCO Board approved amendments to the Intergovernmental Agreement the Agency has with each of its 44 members. The amendment adds another option for members to consider as it relates to the Alternate Director position. Previously a past mayor or village president did not qualify to serve as an alternate. This change allows smaller community members that may have limited staff the ability to appoint a previously participating Mayor to continue to so long as the member's elected board approves the appointment. Both the SWALCO Executive Board and Full Board approved the amendment.
