Neighborhood: Stonebrook-area Neighborhoods;
Beats 59, 60, 73, and 74

Stonebrook area neighborhoods had their most recent neighborhood watch meeting on 09/25/19. The meeting was led by Officer Nauseda. All of the number below represent police calls from January 1 - June 30, 2019.

Police Activity Summary (Patrol Beat 59):

Patrol Beat 59 encompasses homes on and surrounding Camden Drive, Bentley Dr., Arlington Ln., etc. There were 432 police calls for service and 10 of those calls were for actual crimes. The rest of the police calls are considered quasi-criminal, traffic, and service-related.

Police Activity Summary (Patrol Beat 60):

Patrol Beat 60 encompasses properties near Route 132 and Hunt Club Rd. which is an extraordinarily active area of our community. They had 1,973 police calls for service and 82 of those calls were for actual crimes. The rest of the police calls are considered quasi-criminal, traffic, and service-related.

Police Activity Summary (Patrol Beat 73):

Patrol Beat 73 encompasses homes on and surrounding Dada Dr., Bennington Dr., Suffolk Ct., etc. This area had 92 police calls for service and 2 of those calls were for actual crimes. The rest of the police calls are considered quasi-criminal, traffic, and service-related.

Police Activity Summary (Patrol Beat 74):

Patrol Beat 74 encompasses homes within Woodside Park and on and surrounding Foxworth Ln., Portsmouth Circle, Sumner Circle, etc. It also includes the Hunt Club Park property. There were 259 police calls for service and 5 of those calls were for actual crimes. The rest of the police calls are considered quasi-criminal, traffic, and service-related.

Crime Prevention:

Officer Nauseda led a discussion about the cannabis law that will go into effect on January 1, 2020 and the impact it may have in our Village. The Village Board is also considering the option to allow a recreational dispensary in town, based on the guidelines of the new law. Residents were encouraged to visit the Village of Gurnee website to take a short survey to express their opinion on the topic.
